## Admission requirements

On this page you will find important details of the application process (such as deadlines, admission requirements, required documents and application assessment) for the master's programme in Econometrics and Operations Research for the *academic year 2025-2026*.

## Application deadlines

## Are you a non-EU citizen requiring a visa/residence permit for study?

Please note that Maastricht University can **only** formally apply for your visa/residence permit if you have met all admission and enrolment requirements.

This means you have to have completed all admission and enrolment tasks in the MyApplication portal (except the tasks 'Arrange visa / legal residence' and 'Send certified copy of diploma') before we can send your application to the IND (Dutch Immigration and Naturalisation Service).

We have to send the application to the IND **before 1 July if you are starting your studies in September**. Please note: A few pre-master's and master's programmes offer a start in February.

If you are applying to start your studies in February, we have to send the application to the IND before 1 December. You can find out if your study programme offers a start in February on the admission requirements web page of that programme ([pre-master's](#), [master's](#)).

Therefore, we **strongly recommend** that you reconsider applying for this study programme if you are not sure that you will meet the following requirements before 1 July/1 December (if applicable in your situation):

- Having remedied all subject and/or language deficiencies (if applicable)
- Having qualified for admission to your study programme, including being selected ([if applicable to your study programme](#)) AND
- Having paid the tuition fee for your study programme

## Required documents based on your educational background

### With which degree are you applying?

#### Relevant Dutch or Flemish NVAO-accredited diploma

If you have a bachelor's diploma from a Dutch university, you qualify for admission. If your bachelor's or master's programme is mentioned on the list of [relevant NVAO-accredited programmes](#), the following documents are required for your application:

- **Grades transcript of your bachelor's programme**  
*Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.*
- **Copy of your diploma** (if obtained)
- **Curriculum vitae**  
*List your education, relevant extracurricular activities, internships and (professional) experience.*
- **Motivation letter**  
*Provide good arguments for why you want to do this master's programme at Maastricht University and why you expect that you can successfully complete the programme. This letter should be about 1 or 2 pages long.*
- **A recent passport picture**

- **A copy of your valid passport or your EU/EEA identity card**

## UM School of Business and Economics diploma

If you are a student at Maastricht University (UM) and you have one of the following diplomas or certificates, you meet the admission requirements for this master's programme. However, you still need to apply through Studielink and complete the tasks in the MyApplication portal before the deadline mentioned above.

- A UM bachelor's degree in Econometrics and Operations Research

Except for a copy of your valid passport, you do not need to upload any other documents via the MyApplication portal.

## Dutch university diploma

If you have a bachelor's diploma from a Dutch university in a field related to Business, Computer Science, Economics, Econometrics, Engineering, Mathematics, Liberal Arts or Physics, you qualify for admission. The following documents are required for your application:

- **Grades transcript of your bachelor's programme**  
*Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.*
- **Copy of your diploma** (if obtained)
- **Curriculum vitae**  
*List your education, relevant extracurricular activities, internships and (professional) experience.*
- **Motivation letter**  
*Provide good arguments for why you want to do this master's programme at Maastricht University and why you expect that you can successfully complete the programme. This letter should be about 1 or 2 pages long.*
- **Proof of academic capabilities**  
*Demonstrate your academic capabilities by choosing one of the options below:*
  - Option 1: Submit a [portfolio](#). Please use the standard template and insert all your proof into the file.
  - Option 2: GMAT Exam with a test score of 515 or more.

- Option 3:

*GMAT Exam (old version) with a total score of 550 or higher and a minimum score of 4.0 on the Analytical Writing Assessment.*

- Option 4: *GRE test with a score that is equivalent to the minimum GMAT scores (old exam).*

## **International bachelor's diploma**

If you are an international student with a bachelor's diploma from a university or university of applied sciences in a field related to Business, Computer Science, Economics, Econometrics, Engineering, Mathematics, Liberal Arts or Physics, you qualify for admission. The following documents are required for your application:

- **Grades transcript of your bachelor's programme**  
*Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.*
- **Copy of your diploma** (if obtained)
- **Curriculum vitae**  
*List your education, relevant extracurricular activities, internships and (professional) experience.*
- **Motivation letter**  
*Provide good arguments for why you want to do this master's programme at Maastricht University and why you expect that you can successfully complete the programme. This letter should be about 1 or 2 pages long.*
- **Proof of academic capabilities**  
*Demonstrate your academic capabilities by choosing one of the options below:*
  - Option 1: Submit a [\*portfolio\*](#). Please use the standard template and insert all your proof into the file.
  - Option 2: *GMAT Exam with a test score of 515 or more.*
  - Option 3:

In addition:

- Students who have received their prior education in a non-EU/EEA country need to **pay the [€100 handling fee](#)**
- Students with a non-EU/EEA nationality need to submit **proof of [English proficiency](#)**

## **Relevant Dutch pre-master's programme**

If you have successfully finished a [relevant pre-master's programme](#), you meet the admission requirements for this master's programme. The following documents are required for your application:

- **Grades transcript of your pre-master's and bachelor's programme**
- **Copy of your diploma** (if obtained)
- **Certificate of enrolment for the pre-master's programme**
- **A statement from the university of your pre-master's programme indicating that you have finished the programme successfully**
- **A recent passport picture**
- **A copy of your valid passport or your EU/EEA identity card**

## How do we assess your application?

When you want to apply or are applying to this study programme, it is useful to know how we assess your application. You can find more information about this [here](#).

The Board of Admission evaluates the quality of your application by looking at your GMAT score/Proof of Academic Capabilities (if applicable), IELTS/TOEFL score (if applicable), Grade Point Average, the level of statistics and mathematics and at how well your bachelor's programme corresponds with the master's programme. Besides this, the Board looks at your motivation, relevant work experience, international experience and extra-curricular activities. Based on this information, the Board of Admission will decide whether you can be admitted to the programme or not.

Assessment happens **on a rolling basis**. This means that, once you submit a complete file with all the minimum required scores, it will be presented to the Board of Admission. We will not wait until the deadline before we present your file to the Board. You will receive a **decision within 2-4 weeks** after completion of your file.
