On this page you will find important details of the application process (such as deadlines, admission requirements, required documents and application assessment) for the master's programme in European Studies for academic year 2025-2026.

For the master's programme in European Studies enrolment is based on your quality and suitability. For this your motivation, previous education and your (professional) experience are important. You are expected to have prior knowledge of contemporary European history, the integration process, and institutions of the European Union. Some previous insight into theories and methods of social and political science is essential.

Important deadlines for application

This master's programme starts in September.
The deadlines below are applicable for applicants who want to start their studies in September 2025.

Note: if you are viewing this webpage on your phone, we recommend that you use landscape mode.

1 October 2024	Studielink is open for applications for the academic year 2025-2026
1 May 2025, 23:59 CET	Deadline for completing the entire application process for non-EU/EEA applicants (these applicants require a <u>visa or residence permit</u>)
1 June 2025, 23:59 CET	Deadline for completing the entire application process for applicants from the EU/EEA or Switzerland

Please note:

Find out if you can apply for a <u>scholarship</u> or <u>financial aid</u>. Deadlines for scholarships are often earlier than the dates mentioned above.

In Studielink, you need to choose the starting moment. Please make sure to select **September 2025** in the dropdown-menu, so that you will apply for the start of the next academic year.

Are you a non-EU citizen requiring a visa/residence permit for study?

Please note that Maastricht University can **only** formally apply for your visa/residence permit if you have met all admission and enrolment requirements.

This means you have to have completed all admission and enrolment tasks in the MyApplication portal (except the tasks 'Arrange visa / legal residence' and 'Send certified copy of diploma') before we can send your application to the IND (Dutch Immigration and Naturalisation Service).

We have to send the application to the IND before 1 July if you are starting your studies in September. Please note: A few pre-master's and master's programmes offer a start in February. If you are applying to start your studies in February, we have to send the application to the IND before 1 December. You can find out if your study programme offers a start in February on the admission requirements web page of that programme (pre-master's, master's).

Therefore, we **strongly recommend** that you reconsider applying for this study programme if you are not sure that you will meet the following requirements before 1 July/1 December (if applicable in your situation):

- Having remedied all subject and/or language deficiencies (if applicable)
- Having qualified for admission to your study programme, including being selected (<u>if applicable to your study programme</u>) AND
- Having paid the tuition fee for your study programme

General requirements: previous education

The admission requirements for academic year 2024/25 for the master's programme in European Studies depend on your previous education. Please check below which requirements apply to you.

Graduates from the UM bachelor's programme European Studies applying for a continuing Master

If you apply via Studielink for the continuing master's programme, with a UM BA European Studies diploma, you are guaranteed a place. Please note: you must have graduated from BA European Studies at Maastricht University before 1 September 2025.

You will be asked to upload a valid passport/ID (if the one we have on file will not be valid on 1 September 2025) in the

MyApplication portal. You will not have to upload a portrait picture or a letter of motivation.

Graduates from a relevant university bachelor's programme

You qualify for admission if you have a bachelor's degree from a European Studies programme, or from a relevant academic field, and/or have followed some modules on European Union. Relevant fields are for example: political science, international relations, law, economics, contemporary history. You should have obtained good marks in your prior qualifications and have relevant work experience. Please make sure this is pointed out in your CV.

Graduates from another bachelor's programme

Applicants with a relevant university of applied sciences degree (e.g. HBO/Hochschule), or an academic BA or BSc Bachelor in a field that does not grant direct admission into this programme (such as languages or cultural studies), can follow a pre-master year. Once successfully completed, this will then guarantee you access to the master's programme in European Studies.

Additional requirements

Language requirements for English-language master's programmes

As English is the language of instruction in this study programme, it is essential that your English language skills are good enough for you to undertake intensive and challenging academic courses that are taught and examined in English.

Applicants who received their previous education in a non-EU/EEA country (handling fee)

Documents required for application process

During the application process for this study programme you will need to complete a number of tasks for which you will often have to upload documents. The list below gives you an insight into what documents you will (and might) need to prepare.

Required documents for all applicants to this _ study programme

A recent passport picture*

This picture must satisfy certain requirements. You can find these requirements in the task description 'Upload portrait picture' in the MyApplication portal.

• A copy of your passport or your EU/EEA identity card*

Make a copy of the page with your personal details. Save this copy as 'passport copy' and not as 'passport picture'. Your passport must be valid on 1 September 2025.

• A copy of your most recent grades transcript and a copy of your bachelor's or master's diploma if you have obtained it If you have not graduated yet, you can upload your official grades transcript from your bachelor's or master's programme.

Your Curriculum Vitae

Please list your education, relevant extracurricular activities and internship/professional experience.

A motivation letter

All candidates must write a letter of motivation. Please provide good arguments about why you want to do this master's programme at Maastricht University and why you believe that you can successfully complete the programme. You are encouraged to discuss the courses covered. More generally, it is advised to mention possible related topics that you might wish to explore in your master thesis. The motivation letter should be between 800 – 1,200 words.

A writing sample

All candidates should provide proof of sufficient academic writing/research skills. The Admission Board asks the candidate to submit an independently written research paper of at least 2,000 words (excluding the footnotes and reference list) preferably (but not mandatorily) on a relevant topic. As an academic sample of writing, the paper should contain intext references and a reference list/bibliography at the end, to demonstrate your ability to write papers according to academic standards. You can use a paper from earlier studies or another occasion. The submitted work should be written in English.

*As a UM student it is not necessary to upload the abovementioned documents in the MyApplication portal. However, if your passport will not be valid on 1 September 2025, then you still have to upload a copy of your passport.

How do we assess your application?

All complete application files (including English language tests) will be assessed by the Board of Admissions. They will try to respond within four weeks.

Based on the documents you have submitted and the admission procedure for your chosen programme, the UM decides on whether to admit you. Once UM has made a decision on your admissibility, you will be informed about this by email.
