Are you a non-EU citizen requiring a visa/residence permit for study?

Please note that Maastricht University can **only** formally apply for your visa/residence permit if you have met all admission and enrolment requirements.

This means you have to have completed all admission and enrolment tasks in the MyApplication portal (except the tasks 'Arrange visa / legal residence' and 'Send certified copy of diploma') before we can send your application to the IND (Dutch Immigration and Naturalisation Service).

We have to send the application to the IND **before 1 July if you are starting your studies in September**. Please note: A few pre-master's and master's programmes offer a start in February.

If you are applying to start your studies in February, we have to send the application to the IND before 1 December. You can find out if your study programme offers a start in February on the admission requirements web page of that programme (pre-master's, master's).

Therefore, we **strongly recommend** that you reconsider applying for this study programme if you are not sure that you will meet the following requirements before 1 July/1 December (if applicable in your situation):

- Having remedied all subject and/or language deficiencies (if applicable)
- Having qualified for admission to your study programme, including being selected (if applicable to your study programme) AND
- Having paid the tuition fee for your study programme

With which degree are you applying?

Relevant Dutch or Flemish NVAO-accredited diploma

If you have a bachelor's diploma from a Dutch university, you are eligible for admission. If your bachelor's or master's programme is mentioned on the list of <u>relevant NVAO-accredited</u> <u>programmes</u>, the following documents are required for your application:

- Grades transcript of your bachelor's programme
 Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.
- Copy of your diploma (if obtained)
- Curriculum vitae

List your education, relevant extracurricular activities, internships and (professional) experience.

Motivation letter

Provide good arguments for why you want to do this master's programme at Maastricht University and why you expect that you can successfully complete the programme. This letter should be about 1 or 2 pages long.

- A recent passport picture

Applicants from UM SBE or FPN

If you have a Maastricht University (UM) pre-master's certificate in Human Decision Science, you meet the admission requirements for this master's programme. However, you still need to apply through Studielink and complete the tasks in the MyApplication portal before the deadline mentioned above. Except for a copy of your valid passport, you do not need to upload any other documents via the MyApplication portal.

If you are a student at Maastricht University with a bachelor's degree from SBE or FPN, you are eligible for admission. The following documents are required for your application:

• Grades transcript of your bachelor's programme

Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.

Copy of your diploma (if obtained)

Curriculum vitae

List your education, relevant extracurricular activities, internships and (professional) experience.

Motivation letter

Provide good arguments for why you want to do this master's programme at Maastricht University and why you expect that you can successfully complete the programme. This letter should be about 1 or 2 pages long.

- Two names of members of the SBE or FPN teaching staff who supervised or taught you during your bachelor's programme
- A recent passport picture
- A copy of your valid passport or your EU/EEA identity card

Students from another UM bachelor's programme can check the requirements under 'Relevant NVAO-accredited study programme' or 'Other Dutch university degree'.

Dutch university diploma

If you have a bachelor's diploma from a Dutch university, you are eligible for admission. The following documents are required for your application:

• Grades transcript of your bachelor's programme

Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.

Copy of your diploma (if obtained)

International AACSB or EQUIS accredited diploma

If you are an international student with a bachelor's diploma from a university or university of applied sciences, you are eligible for admission. If your bachelor's or master's programme is <u>AACSB or EQUIS accredited</u>, you need to provide proof of this (e.g. a stamped and signed transcript of grades). Please note that the burden of proof rests with the applicant. The following documents are required for your application:

Relevant Dutch pre-master's programme

If you have successfully finished a <u>relevant pre-master's programme</u>, you meet the admission requirements for this master's programme. The following documents are required for your application:

- Certificate of enrolment for the pre-master's programme
- A statement from the university of your pre-master's programme indicating that you have finished the programme successfully.
- A recent passport picture
- A copy of your valid passport or your EU/EEA identity card

Dutch HBO diploma

If you have a Dutch bachelor's diploma from a university of applied sciences (HBO), you are eligible for admission. The following documents are required for your application:

- Grades transcript of your bachelor's programme
 Upload an official grades transcript, signed and stamped by your university, plus a translation if the original is not in English.
- Copy of your diploma (if obtained)

How do we assess your application?

When you want to apply or are applying to this study programme, it is useful to know how we assess your application. You can find more information about this here.

The Board of Admission evaluates the quality of your application by looking at your GMAT score/Proof of Academic Capabilities (if applicable), IELTS/TOEFL score (if applicable), Grade Point Average, the level of statistics and mathematics and at how well your bachelor's programme corresponds with the master's programme. Besides this, the Board looks at your motivation, relevant work experience, international experience and extra-curricular activities. Based on this information, the Board of Admission will decide whether you can be admitted to the programme or not.

Assessment happens **on a rolling basis**. This means that, once you submit a complete file with all the minimum required scores, it will be presented to the Board of Admission. We will not wait

| until the deadline before we present your file to the Board. You will receive a decision within 2-4 weeks after completion of your file. |
