Foreword

In 2016, as in previous years, the Maastricht Centre for European Law hosted the research activities of the large group of scholars based at Maastricht University who engage with European Union law. MCEL organised once again a series of workshops and research seminars, both in Maastricht and in Campus Brussels of Maastricht University, and the publications produced by its members continue to cover a broad range of questions of EU law.

MCEL members have been actively engaging with society on a number of topics. Elise Muir and Vigjilenca Abazi appeared before the European Parliament in hearings. Marcus Meyer was interviewed on his empirical work on Dutch central works councils by 'Praktijkblad Ondernemingsraad'. Francesca Galli commented on the terrorist attacks in Brussels before Italian television. Sarah Schoenmaekers spoke before the American Bar Association about fraud and corruption in European public procurement and the ways to tackle anti-competitive behaviour. Ellen Vos wrote a blog on EU agencies and started, together with colleagues from legal, political and social disciplines, a dialogue with various practitioners on the challenges posed by the ongoing agencification. Lisa Waddington actively contributed to the debate on the consequences of the British referendum in June.

Faced with the results of the UK referendum and the US presidential elections, as well as in the framework of the commemorations of the 25th Anniversary of the Maastricht Treaty, MCEL members have reflected on the past and future of the European Union. MCEL feels evermore committed to its in-depth academic research on issues of European integration and its mission to actively contribute to the debate on the future of Europe. MCEL will continue to study the challenges the EU currently faces and identify the legal issues at stake in its future academic research.


