Composition of the Council in 2020-2021

The University Council (UC) consisted of 20 members in 2020-2021, with ten people from the student delegation (L. van Galen (Chair Strategy committee), L. Bierens, Y. Hashish, A. Voncken, E. Stevens, B. Dela Haije, A. Hannaford, F. Leppert, F. Senger, T. Vaessen), four from the support staff delegation (W. Klinkhamer (Chair Operations committee), P. Harbers, N. Dirks, M. van Wesel,), and six from the scientific staff delegation (M. Siegel, J. Schell (Chair R&E committee), M. Govers, R. Luja (Chair of the confidential committee of the UC), J. de Roder, K. Kuypers).

The Council was chaired by A. Kluveld (chair) and A. Voncken(vice-chair).

Public meetings of the Council

In 2020-2021 the University Council (UC) met **eleven** times in its **plenary** meeting to discuss a list of topics (see **list 1** below). The presidium met weekly to discuss the daily business of the UC. The presidium made announcements about the (re)appointment of CBE members and about the treasurer board of the Observant Foundation. The members of the committees met **nine** times to discuss topics that were either discussed only in the respective committees (see list 2 below) or were put on the agenda of the plenary meeting. The confidential committee of the UC discussed the nomination for the honorary doctorate and the Tanspenning.

Dates of council meetings

The plenary meetings took place four times in 2020 (23-09; 28-10; 25-11; 16-12) and seven times in 2021 (27-01; 24-02; 24-03; 21-04; 26-05; 23-06; 14-07). The committee meetings took place four times in 2021 (09-09; 07-10; 11-11; 09-12) and five times in 2021 (10-02; 10-03; 07-04; 12-05; 09-06).

Internal meetings

Next to the official meetings, the UC also organized **two theme days** (14-10-2020 and 14-04-2021), to discuss internal workings and brainstorm about predefined topics (Good governance, diversity, growth of UM including work pressure, student-staff ratio, quality of research and education, facilities, housing in the city; Whether there is a road map to grow; what the vision of UM is on the expected growth and what the ambitions are). One letter was sent to the EB (budget letter in relation to the Funding Framework memorandum). The UC also traditionally met twice with the Supervisory Board to exchange ideas in December and May.

Summary

The UC discussed a wide range of themes concerning UM policies, progress reports of running projects, the initiation of new projects, planned investments, and the budget, and the measures taken due to corona, amongst others.
