- **Chiara Scapinello** – March 2021 – September 2021



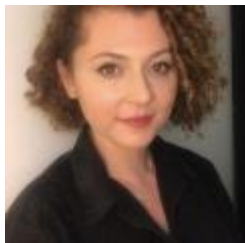
