## **Curriculum: 60 ECTS**

#### The students enrolled in one of the specialisations must:

- Pass the two core courses (12 ECTS in total)
- Pass the mandatory specialisation course of their track (6 ECTS)
- Earn 18 ECTS in specialisation courses (three specialisation courses)
- Earn 12 ECTS in elective courses
- Pass thesis (12 ECTS)

#### The students enrolled in the Free Programme must:

- Pass the two core courses (12 ECTS in total)
- Earn 24 ECTS in Free Programme courses (four courses)
- Earn 12 ECTS in elective courses
- Pass thesis (12 ECTS)

(4th period = Feb / Mar)







# The specialisation courses

#### **Human Rights Law**

➤ Int'l Human Rights Law (mandatory); Dispute Settlement; Int'l Humanitarian Law; Human Rights of Women; Human Rights and Human Development; Int'l Criminal Law.

#### **Corporate and Commercial Law**

Comparative Commercial Law (mandatory); Int'l Trade Law; European Competition Law; Int'l Commercial Dispute Resolution; Int'l Commercial Law; Comparative Corporate Governance.

#### **Trade and Investment Law**

➤ Int'l Trade Law (mandatory); Advanced Int'l Trade Law; Intellectual Property Law; Law and Economics; Int'l Investment Law; Human Rights and Human Development; The Law of the Economic and Monetary Union.





### **Elective courses**

#### For the students enrolled in a specialisation

- One of the two remaining specialisation courses
- One or two specialisation courses from the other two specialisations
- A moot court
- An internship
- An LLM course from other Faculties or ours, subject to prior authorisation by our Faculty (6 ECTS, max)

#### For the students enrolled in the Free Programme

- One or two more specialisation courses
- A moot court (12 ECTS, but 6 are extracurricular)
- An internship (up to 12 ECTS)
- An LLM course from other Faculties or ours, subject to prior authorisation by our Faculty (6 ECTS, max)

## **Thesis**

- Topic chosen in consultation with supervisor
- Should fit with specialisation
- Must be between 8,000 and 10,000 words
- Periods 3 (Jan) and 6 (Jun/Jul)
- The importance of writing a good thesis cannot be overstated





## **Internships**

- Students may register for only one internship per specialisation
- May account for up to and no more than 6 or 12 ECTS
- For at least 20 working days => 6 ECTS. For at least 40 days => 12 ECTS
- In principle, must be undertaken on a full-time basis
- Part-time may be permitted, but for not less than 2 working days per week
- Aim is to enable students to deepen their academic knowledge by experiencing some kind of legal professional practice
- Internship plan must be submitted for approval at least 4 weeks before the start
- Restrictions: plan submitted for approval after the start of the internship; employment relationship; carried out in offices run by family members; work from home.

## **Admission requirements**

#### A bachelor's degree in law from:

- NL, or
- A comparable degree from abroad.

or

#### A (bachelor) degree from:

- Higher vocational education institute, or
- A university in a field other than law.

N.B.: In the latter case, entrance exam is required.

- November and May
- Computer-based (on-line)

Applicants who are non-native English speakers and have their undergraduate degree in a language other than English must meet one of the following requirements:

- <u>IELTS</u> minimum score overall 6.5 & writing 6.5, or an overall score of minimum 7;
- <u>TOEFL</u> internet-based minimum score 90 with a writing score of minimum 25, or an overall score of 100; or,
- Cambridge examinations: minimum score of C.



### **Master's Honours Research Track**

- From January to June.
- Aims to further develop academic research skills.
- In consultation with their supervisor, students may write an extended thesis and get 12 ECTS.
- Students prepare themselves for a future PhD or academic career.
- Completion of the Honours Programme leads to 15 extracurricular ECTS.
- Students who successfully complete the programme will receive a Law Honours Research Track certificate together with their master's degree.
