Addendum to Chapters VII Study abroad requirement, XIII Fulfillment of the Bachelor's Exam Requirements, XVI SBE Bachelor's study programmes of the BSc EER 2022-2023 for the Spring 2023 Study Abroad Requirement.

Article 1 Applicability

- 1. This addendum is applicable to students who, according to their regular study outline, should normally fulfill their study abroad requirement (as laid down in chapters VII, XIII and XVI of the SBE BSc EER 2022-2023) in the second semester of academic year 2022-2023.
- 2. This addendum provides students with the possibility to do an alternative programme to the study abroad requirement of 26.0 ECTS credits and is applicable to students from the following BSc programmes and/or specialisations in the second semester of academic year 2022-2023:

- 3. This addendum is applicable to the above mentioned students:
 - A. whose receiving institution cancelled its incoming exchange; and/or
 - B. who cannot travel due to government-imposed restrictions to their receiving institution.

Article 2 Postponement of the study abroad programme

If the receiving institution cancels its incoming exchange programme in the Spring 2023 semester, students can only postpone their study abroad programme to the Fall 2023 semester if the partner university offers SBE additional places on top of the places already reserved for the students that were supposed to fulfill their Study Abroad requirement in the Fall 2023.

Article 3 Alternative programme to fulfill the study abroad requirement for students that fall under Article 1

- Students can choose to do and must successfully complete the following international alternatives in the second semester of academic year 2022-2023 to fulfill the study abroad requirement of 26.0 ECTS credits:
 - A. The study abroad as planned at the partner university via online education if this is offered. Please note that any difficulties with following online education at a partner university (e.g. different time zones) is the responsibility of the students themselves.
 - B. An internship abroad of 26.0 ECTS credits. Procedures and/or guidelines for these internships are published by the Internship Office on the MySBE Intranet.

¹ Students in this specialisation can also opt to do an international internship. This chapter of this addendum to the EER only regards students who have chosen to participate in study abroad.

- 2. Additionally, students can fulfill the study abroad requirement of 26.0 ECTS credits in the second semester of academic year 2022-2023 (ultimately 31 August 2023) by taking the (obligatory) skill training ESA9002 Global Citizenship (4.0 ECTS credits) and combining this with the following local alternatives up to 22.0 ECTS credits:
 - C. An internship in the Netherlands of minimal 22.0 ECTS credits. Procedures and/or guidelines for these internships will be published by the Internship Office.
 - D. An alternative programme with a minimum of 22.0 ECTS credits at SBE. The courses can be freely chosen from the list of 3rd year courses from the study programme that the student is enrolled in.
 - E. Students enrolled in the BSc Econometrics & Operations Research (EOR) can obtain credits from courses offered by the Department of Advanced Computing Sciences (DACS), formerly known as Department of Knowledge Engineering (DKE). Note that such courses have a limited capacity and may require certain pre-requisites. EOR students must obtain at least half of the ECTS credits (11) in quantitative courses (e.g. Econometrics, Finance, Economics, Computer Science, Mathematics), and no courses should have significant overlap with courses of the regular programme.
 - F. A combination of options D and E for EOR students with a minimum of 22.0 ECTS credits (i.e. regular SBE courses in combination with courses from DACS).
- 3. Students choosing one of the options mentioned under paragraph 1 and 2 of this Article, have to request the option with the International Relations Office before the start of the second semester of academic year 2022-2023. The International Relations Office is mandated by the Board of Examiners to approve the choice of alternative programmes if the student fulfills the requirements.
- 4. The options mentioned under paragraph 1 and 2 of this Article, can only be used for fulfilling the study abroad requirement if the student has successfully completed the chosen option and has received the ECTS credits for it. If the student chooses for option D, E or F under paragraph 2, the results of the courses will be added to the curricular transcript and will consequently be included in the GPA of the student.

Article 4 Unsuccessful completion of the alternative programme

For students who started the alternative programme for the first time in the second semester of academic year 2022-2023 and who have not successfully completed the chosen alternatives within this second semester, the regulations of Chapter VII of the SBE BSc-EER 2022-2023 apply. This means that:

- 1. Students who have successfully obtained 22.0 ECTS credits or more in the alternative programme as indicated in Article 3 paragraph 1 and 2, can complete their study abroad requirement with the curricular summer or winter course as per Article 7.5 in the SBE BSc-EER 2022-2023 or with the curricular internship with a maximum of 4.0 ECTS credits as per Article 7.6 in the SBE BSc-EER 2022-2023. Please note that Article 7.7 of the SBE BSc-EER 2022-2023 also applies.
- 2. Students who have obtained less than 22.0 ECTS credits must complete their study abroad requirement by obtaining the remaining ECTS credits by doing and successfully completing (a combination of) the alternatives D, E or F of Article 3 paragraph 2 of this addendum before 31 January 2024. The Global Citizenship course (ESA9002) is part of this requirement, unless one of the following requirements applies:
 - a. The student participated in alternatives A or B of Article 3 paragraph 1 and successfully obtained 13.0 ECTS credits or more; or
 - b. The student participated in alternatives C, D, E or F of Article 3 paragraph 2 of this addendum and has successfully completed the Global Citizenship course (ESA9002) in their alternative programme.
- 3. Students who have not been able to obtain a minimum of 26.0 ECTS credits for the study abroad requirement before 31 January 2024, must complete their study abroad requirement by obtaining the remaining ECTS credits in a new semester study abroad.

Article 5 Transitional regulations for repeat students

In light of the end of many additional regulations due to the covid-19 pandemic, the addenda on the study abroad requirement of the academic years prior to academic year 2022-2023 no longer apply. To make sure the students who made use of these addenda on the study abroad requirement who have not successfully completed their alternative programme in academic year 2020-2021 or academic year 2021-2022 still have the option to do so, SBE has created a transitional period until 31 January 2023 for these students to successfully complete their study abroad requirement.

- 1. This article applies to students who:
 - a. can prove that they have started their alternative programme for the study abroad requirement prior to September 2022; and
 - b. who have not obtained the required 26.0 ECTS credits to complete their study abroad requirement.
- 2. Students who have obtained less than 26.0 ECTS credits in the offered alternative programme options in academic years 2020-2021 and 2021-2022 must obtain the remaining ECTS credits to a minimum total of 26.0 ECTS credits by doing and successfully completing (a combination of) the alternatives D, E, F, or G of Article 3 paragraph 2 of the addendum BSc EER 2022-2023 Fall Study Abroad Alternatives before 31 January 2023. The Global Citizenship course (ESA9002) is part of this requirement, unless one of the following requirements applies:
 - a. The student participated in alternative B of Article 3 paragraph 1 of the addendum BSc EER 2022-2023 Fall Study Abroad Alternatives and successfully obtained 13.0 ECTS credits or more; or
 - b. The student participated in alternatives C, D, E, F or G of Article 3 paragraph 2 of the addendum BSc EER 2022-2023 Fall Study Abroad Alternatives and has successfully completed the Global Citizenship course (ESA9002) in their alternative programme.
- 3. Students who have not been able to obtain a minimum of 26.0 ECTS credits for the study abroad requirement before 31 January 2023, must complete their study abroad requirement by obtaining the remaining ECTS credits in a new semester study abroad.
