## Article 2 Adjustment resit period for course period 2 educational units

- If a student, as defined in Article 1 paragraph 2 of this addendum, fails to successfully complete or receives a No Grade as defined in Article 4.18 of the SBE BSc EER 2023-2024 for one or more of the educational units as defined in table 1 of this addendum, the resit of the respective educational unit(s) will take place on 29 and/or 30 January 2024 (specified as the QM3 Skills exams period in the Academic Calendar 2023-2024) instead of the in period 4 scheduled Resits courses P2&3 as communicated in the Academic Calendar 2023-2024 published on MySBE Intranet.
- 2. Students who fail to successfully pass the resit(s) in course period 3 or receive a NG for the respective resit(s), will have to participate in the regular examination period of the respective educational unit(s) in semester 1 of academic year 2024-2025 to be able to successfully complete their SBE Pre-master in International Business in the required two (2) academic years as stated in Article 20.6 paragraph 4 of the SBE BSc EER 2023-2024.
