

Vacancy: Student members Educational Programme Committees Faculty of Law (FoL)

The application procedure for the respective Educational Programme Committees (EPC's) of the European Law School, Dutch Law, Tax Law and Privacy, Cybersecurity and Data Management has begun! **Our faculty is in search of keen and enthusiastic candidates who wish to work as student representatives during the academic year of 2024-2025.**

The EPC's are the FoL's participation body for the Faculty's offered education programmes. They advise the Faculty Board (FB) on matters related to improving and guaranteeing the quality of the programmes. Each EPC consists half of students and half of staff involved in the respective programmes. This vacancy is aimed at student members for:

- EPC Dutch Law (Bachelor (BA) Rechtsgeleerdheid, including Dutch masters)
- EPC Tax Law (BA Fiscaal Recht, including Tax masters)
- EPC European Law School (BA ELS, including English masters)
- EPC Advanced Master in Privacy, Cybersecurity and Data Management (ECPC)

The EPC's provide students with an excellent opportunity to discuss academic issues. They may offer solicited and unsolicited advice to the FB. Major agenda items include the quality and feasibility of the programmes. Depending on the subject, the EPC has the right to consent and advisory powers on various matters relating to education. For example, right of consent on the content of specialisations within a programme, the quality of the curriculum and the manner of evaluation. Programme changes, changes in examination regulations and proposals for new programmes will be submitted to the EPC's for advice. In addition, the EPC can also take the initiative to advise the Director of Studies and the Faculty Board on all matters relating to education in the relevant study programmes.

The Dutch Law, Tax Law and European Law School EPC's can meet jointly or separately, they meet about once a month. The EPC ECPC meets about four times a year. At the first meeting of the academic year, members jointly decide whether to speak in Dutch or English.

Function description:

General information regarding this position:

- The position is eligible for monetary compensation.
- It requires active participation in EPC meetings, which occur for the EPC Dutch Law, Tax Law and European Law School on a monthly-basis respectively on Wednesdays (educational re-scheduling is possible).
- It requires active participation in meetings of the Student Council, which occur on a monthly-basis respectively on Wednesday afternoons.
- The term of appointment is for one academic year.

Would you like to provide a student's perspective to programme-specific and faculty issues? Do you have good ideas as to how education is conducted within our faculty? Or are you willing to think broadly about the educational policies of our faculty? Can you come up with clear and structured solutions to dynamic issues and implement them in practice? Then you might be suitable for a position in one of our EPC's!

Selection procedure

The Faculty Board will appoint the EPC student members for a one-year term, with student members being appointed on the recommendation of the student members of the particular EPC and of the Faculty Council. For the EPC's Dutch Law, European Law School and Tax Law we are looking for four student members, for the EPC ECPC we are looking for two student members. A student may serve several terms on an EPC. Current EPC student members may therefore also apply.

When selecting candidates, diversity across specific programme components will be sought as much as possible. For English-taught programmes, efforts are made to ensure adequate representation of the students in those programmes.
