

# Preparations before you travel to the Netherlands

**IMPORTANT NOTICE**; do not book any plane or train tickets or travel to the Netherlands until your legal residence application was approved and you have received a copy of the approval letter.

#### 1. Housing

Your priority is getting a private and personal Dutch address. As this is an absolute necessity to register in the municipality, open a bank account, and meet other obligations, we strongly recommend arranging this as soon as possible. Postponing this until you have arrived in the Netherlands jeopardizes your financial mobility, legal residence, timely start of the program, etc. Finding suitable accommodation after you have arrived is extremely difficult and the address of a hotel, a friend, or the university is not acceptable. A good place to start is the <u>Maastricht Housing</u> (<u>link</u>) website.

Holders of a Dutch residence permit are not allowed to live outside The Netherlands You cannot live in Belgium or Germany even though Maastricht University is close to the border and accommodation may be easier to find.



#### WARNING

Be vigilant of imposters and fraud. We strongly recommend double-checking the reliability of an offer. Do remember: if something sounds too good to be true, it usually is.



### 2. Crucial documents

The following documents are crucial to bring with you and therefore arrange in time:

- A legalized birth certificate: this is compulsory for your municipal registration. Depending on your nationality, the legalization process may be very different and take a lot of time. - Your valid passport
- The health insurance policy

### 3. Health insurance

If you do not have health insurance yet, or if your current insurance policy does not (sufficiently) cover your stay in the Netherlands, you have to take out health insurance before traveling to the Netherlands or immediately upon arrival. ### 4. Money

Since cash payments in the Netherlands are getting less and less and paying by credit card is not always possible, you may want to consider the following. You can open an online bank account without the need for a social security number (BSN) to have quick access to your money and make payments easily. Please keep in mind that when you made a deposit to the Maastricht University Visa Office, this will not be refunded before your first day of registration. We strongly recommend preparing for this.

## And after my visa/residence permit is approved?

As soon as the decision on the residence permit application is received, we will inform you on the following items:

- 3. Collection of the residence permit and municipal registration
- 4. Opening a Dutch bank account
